2. DATA PROCESSING PURPOSES

3. LEGAL BASIS FOR DATA PROCESSING

The legal basis for the processing of your personal data is:

4. DATA RECIPIENTS

5. DATA PROCESSING PERIOD

6. RIGHTS OF DATA SUBJECTS
