Rules of participation in the TechGenalia 2025 conference - 03-04.07.2025 in Warsaw

§ 1. GENERAL PROVISIONS

- 1. The Rules define the terms and conditions of participation in the conference called TechGenalia 2025 organized by GE Medical Systems Polska Sp. z.o.o. with its registered office in Wołoska 9, 02-583 Warsaw.
- 2. The conference will be held on 03-04.07.2025 at the DoubleTree by Hilton Hotel, ul. Skalnicowa 21, Warsaw.
- 3. The Rules are addressed to all persons participating in the conference. Each person who has received electronic confirmation of registration or is staying in the area where the conference is held is obliged to comply with the provisions of these Rules.
- 4. These regulations shall enter into force on the date of their posting on the website on 23.03.2025.
- 5. The purpose of the Regulations is to ensure the safety of the Conference by defining the rules of conduct of persons present at the Conference and their use of the facility in which the Conference is held, as well as the devices located in the facility.

§ 2. DEFINITIONS

For the purposes of these regulations, the following definitions have been specified:

- a) Regulations means this document containing a set of rules and conditions of participation in the conference, available on the website at: www.techgenalia.pl
- b) Organizer means GE Medical Systems Polska Sp. z.o.o. with its registered office in Warsaw, ul. Wołoska 9, 02-583 Warsaw.
- c) Conference means the conference organized by the organizer under the name: TechGenalia 2025, taking place on 03-04.07.2025 at the DoubleTree by Hilton Hotel ul. Skalnicowa 21, Warsaw.
- d) Application means the notification to the organizer of the willingness of a given natural person to participate in the conference by filling out the application form.
- e) Application form means the form available on the website: www.techgenalia.pl, through which the application is made.

- f) Confirmation of application means a message sent by the organizer to the e-mail address provided by the participant in the application process, confirming the acceptance of the application and the commencement of its processing.
- g) Registration means the positive processing and consideration of the participant's application, which is a condition for the participant's participation in the conference.
- h) Confirmation of registration means a message sent by the organizer to the e-mail address provided by the participant in the application process, confirming the participant's registration for the conference.
- i) Participant means the natural person who was indicated in the application form and who received confirmation of registration.
- j) Privacy Policy a set of rules and regulations specifying the method of processing participants' data. The Privacy Policy constitutes Annex No. 1 to the regulations.

§3. TECHNICAL REQUIREMENTS

- 1. Registration, submission and browsing the website require an Internet connection via a personal computer or mobile devices with access to the following browsers:
- Mozilla Firefox version 70 or higher,
- Google Chrome version 70 or higher,
- Safari version 12 or higher,
- Opera version 66 or higher.

§ 4. CONDITIONS OF PARTICIPATION

- 1. The condition of participation in the conference is to submit an application via the application form available on the conference website at: www.techgenalia.pl and receive confirmation of registration, as well as to read and accept these Regulations, the Information Clause for Participants (available on the website: https://www.gehealthcare.pl/about/privacy/privacy-policy?showPopup=false) and the Privacy Policy.
- 2. Participants may only be persons who have contact with medical devices in their professional activity as professionals; representatives of entities conducting medical activity, related to the use of medical devices; persons who, due to their profession, function or business activity, participate in the

trade in medical devices; persons with medical or specialist knowledge who have received an invitation from the Organizer to participate in the Conference.

- 3. The Organizer is not responsible for providing incorrect or false data by the Participant during the registration and registration process for the Conference. 4. Participation in the Conference is free of charge. 3. In order to register, the Participant should complete and send the registration form on the website by 5.06.2025. 4. The scope of the system includes the service of storing the user's registration in the database, as well as handling this registration (consisting of collecting, recording, storing, updating, supplementing and deleting this data) by the Organizer. 5. Participants' admission to the Conference takes place on the basis of an electronic confirmation of registration received from the Organizer, sent to the e-mail address provided by the Participant in the registration form.
- 7. The Participant is obliged to immediately, no later than 5 working days before the start of the Conference, inform the Organizer about the withdrawal from participation in the Conference by sending an e-mail to rejestracja@techgenalia.pl
- 8. Each Participant will receive a confirmation of participation a certificate of participation in the Conference. The Participant authorizes the Organizer to send the certificate electronically.
- 9. Upon registration, the Participant consents to the processing of personal data contained in the application form by the Organizer or other entities commissioned by the Organizer for purposes related to the organization and participation in the Conference and marketing purposes, in accordance with the Act of May 10, 2018 on the protection of personal data (Journal of Laws 2019, item 1781, i.e. of 2019.09.19). The consent also covers the processing of personal data in the future, if the purpose of processing does not change. At the same time, the Participant acknowledges that the Organizer is the administrator of personal data and that he/she has the right to view and correct personal data and that providing this data is voluntary but is a condition for participation in the Conference. The Organizer informs that the Participant's consent may be withdrawn at any time, and the withdrawal of consent does not affect the lawfulness of the processing carried out on the basis of consent before its withdrawal.
- 10. The Participant covers the costs of travel on his/her own.
- 11. During the Conference, the Organizer may organize a practical presentation of service activities. For invited Participants, registration will be available via a separate application form. The number of places at the presentations is limited, and participation in them is decided by the order of applications.
- 12. The presentation will be conducted in Polish, the Organizer does not provide translation of the presented content into English or other languages.
- 13. The right to participate in the presentations is only granted to Participants who received a separate invitation and expressed their willingness to participate, and then received confirmation of registration for the presentation from the Organizer.
- 14. The Organizer has the right to refuse entry to the presentation to late Participants.

- 15. During the presentation, recording of image and sound and taking photos by Participants is prohibited.
- 16. During the presentation, the Participant is absolutely obliged to observe safety rules and to comply with these Regulations and the instructions of the presenter.
- 17. The Organizer is not responsible for Participants having the appropriate qualifications, knowledge and competences to participate in the presentation. As part of the presentation, the Organizer will not grant Participants any qualifications.
- 18. Failure to follow the safety rules and instructions of the person conducting the presentation may cause accidents. Each person taking part in the presentations assumes this risk. The Organizer is not responsible for any damages that do not result directly from his/her culpable acts or omissions. These Regulations are not intended to exhaustively indicate all the risks associated with the presentation. In case of any doubts regarding the risks associated with it, please contact the Organizer.

§ 5. COMPLAINTS

- 1. All complaints from Conference Participants against the Organizer should be submitted in writing and sent via e-mail to the following address: rejestracja@techgenalia.pl or to the address of the Organizer's registered office and should include: name and surname of the person submitting the complaint, correspondence address, e-mail address, telephone number, subject of the complaint, date of the event, indication of the factual circumstances justifying the complaint.
- 2. The Participant may submit complaints no later than 2 days after the end of the Conference.
- 3. After the above deadline, no complaints will be considered.
- 4. The Organizer will consider the complaint within 14 business days from the date of receipt of the complaint and will communicate its position to the entity submitting the complaint in the form in which the complaint was submitted.

§6. OBLIGATIONS OF PARTICIPANTS

1. The Participant is obliged to read the Regulations and comply with their provisions.

2. Conference participants and all persons present at the Conference are obliged to behave in a manner that does not endanger the safety of other persons present, and in particular to comply with the provisions of the Regulations and follow the instructions and instructions of the Organizer's representatives, aimed at ensuring their safety and order. 3. - reproduction by any technique,
- public display, reproduction, broadcasting and re-broadcasting,
- lending, renting, lending of media on which the image, voice, statement was recorded,
- entering into computer memory and a multimedia network,
- use on various types of websites (including the organizer's website). 4. By accepting these Regulations, the Participant consents to the use of his image by the Organizer or other persons on behalf of the Organizer, including reproduction using all techniques, distribution and publication in the press, brochures, leaflets, electronic media in connection with the organization, participation, reporting on the course and documentation of the conference if necessary. At the same time, the Participant acknowledges that the Organizer is the administrator of personal data in this part and that he has the right to view and correct personal data and that providing this data is voluntary but is a condition for participation in the Conference. The Organizer informs that the Participant's consent may be withdrawn at any time, and the withdrawal of consent does not affect the lawfulness of the processing carried out on the basis of consent before its withdrawal. 5. Acceptance of these Regulations and participation in the Conference is tantamount to the Participant's consent to the recording, use and/or distribution by the Organizer and entities associated with it of the image/voice/statements of each Participant in all promotional and marketing materials without time or territorial restrictions. At the same time, the Participant authorizes the Organizer to grant further consent in this respect to entities associated with him.
- 6. Expressing consent is tantamount to the fact that photographs, films or recordings taken during the Conference may be placed on the Organizer's website or another website and used in promotional materials, also distributed for this purpose by means of vision or sound. Distribution of the Participant's image/voice/statements for the purposes specified in these Regulations shall be without remuneration.
- 7. The image of the Conference Participants may be recorded on video materials and photographs: image processing in this case shall be based on art. 81 sec. 2 item 2 of the Act of 4 February 1994 on copyright and related rights and shall not require additional consent from the Participant.

§9. FINAL PROVISIONS

1. The Organizer shall make the content of the Regulations available before the beginning of the Conference.

2. The Organizer reserves the right to make changes to the Regulations at any time.
3. Registration in accordance with paragraph 2d) is tantamount to acceptance of these Regulations.
Each new regulation applies to persons who have not yet registered for the Conference or have accepted the new regulations.
4. The number of places for participation in the Conference is limited. Participation in the conference is decided by the order of applications. Applications for the Conference may be submitted from 5.06.2025 and will be accepted until the number of available places is exhausted.
5. The Organizer reserves the right to exclude from participation in the Conference Participants who violate any provisions of these Regulations, in particular:
a) undertake actions that are contrary to the law, good customs or that harm the legitimate interests of third parties; b) undertake actions aimed at circumventing or indicating an attempt to circumvent the Regulations or the principles of holding the Conference;
c) undertake actions violating the legitimate interests of the Organizer or harming its image.
6. The Organizer reserves the right, in the event of circumstances beyond its control, to cancel, partially close, shorten or postpone the Conference to another date.
7. In matters not regulated by these Regulations, the provisions of the Civil Code shall apply accordingly.
8. In the event of a change or invalidation as a result of a final court decision, of any of the provisions of the Regulations, the remaining provisions shall remain in force.

10. The Conference is of a closed nature and does not constitute a mass event within the meaning of the Act of 20 March 2009 on the safety of mass events (Journal of Laws 2023.616, consolidated text of 2023.03.31).

9. Any disputes that may arise from participation in the Conference shall be settled first amicably and

then by a court with jurisdiction over the seat of the Organizer.

11. The Privacy Policy is an integral part of the Regulations. The provisions regarding the amendment of the Regulations shall apply accordingly to changes in the content of the Privacy Policy.
